#### Market Capitalization, Fully Diluted Value, and Liquidity

# Market Capitalization:

- The VA must have a transparent and accurate calculation of its market capitalization.
- Regularly assess and disclose any significant changes in market capitalization.

#### Fully Diluted Value:

- Clearly define and calculate the fully diluted value of the VA.
- Disclose any factors that may impact the fully diluted value.

# Liquidity:

- Evaluate and disclose the liquidity of the VA in relevant markets.
- Implement mechanisms to address liquidity concerns and provide timely updates.

#### **Design, Features, and Use Cases**

#### Design and Features:

- Understand and communicate the technical design and features of the VA.
- Assess the practical implications and risks associated with the design.

#### Use Cases:

- Identify and communicate the intended use cases of the VA.
- Evaluate potential risks arising from unintended or misuse of the VA.

# **Compliance with Applicable Laws and Regulations**

#### Legal Compliance:

 Regularly review and ensure compliance with applicable laws, regulations, rules, and directives. • Establish processes to promptly address any changes in regulatory requirements.

# **AML/CFT, Sanctions, Securities, Intellectual Property:**

- Implement robust AML/CFT controls.
- Ensure compliance with sanctions, securities, and intellectual property laws.
- Periodically assess and update compliance measures.

# **Regulatory Treatment and Approvals**

## **Regulatory Treatment:**

- Understand and document the regulatory treatment of the VA by VARA and other relevant authorities.
- Monitor and promptly address any changes in regulatory status.

# Regulatory Approvals:

- Obtain and maintain regulatory approvals as required.
- Communicate any regulatory approvals received for the issuance of the VA.

# **Prohibition and Compliance**

#### **Prohibition Status:**

#### Future Development and Roadmap:

• Communicate a clear roadmap for the future development of the VA.

 Provide updates on the roadmap as communicated by the Issuer or developers.

# **Price Manipulation and Conflict of Interest**

#### Price Manipulation:

- Evaluate susceptibility to price manipulation and implement relevant mitigations.
- Periodically review and update measures to address potential price manipulation.

#### Conflict of Interest:

- Identify and disclose potential or actual conflicts of interest related to VA activities.
- Implement mitigations to address conflicts and ensure fair practices.

# **Issuer Background and Asset Rights**

#### Issuer Background:

- Conduct due diligence on the background of the VA's Issuer.
- Disclose relevant information about the Issuer's experience and any history of investigations or claims.

# Asset Rights:

- Assess and ensure the enforceability of rights associated with the VA.
- Communicate any rights the VA represents to other assets.

# **Asset Sufficiency and Terms Review**

# Asset Sufficiency:

- Regularly verify and ensure that sufficient assets are available to meet obligations related to VA activities.
- Implement mechanisms to address potential insufficiencies.

#### Terms and Conditions:

- Ensure that VA terms and conditions reflect the operation of underlying physical markets.
- Regularly review and update terms to conform to standards and practices in physical markets.

#### Periodic Review:

- Conduct periodic reviews of VA terms and conditions for correlation with physical markets.
- Promptly update terms to align with evolving standards and practices.
